Individual investors who have held 1,000 shares (approximately 9,000 TL) or more of TAV Airports (TAVHL) stock for 1 (one) year (December 3, 2011 - December 3, 2012) or more will be awarded a **free TAV Passport Card** valid for one year.

Campaign Terms and Conditions:

- ✓ Individual investors who have held 1,000 shares or more of TAV Airports Holding (TAVHL) for 1 (one) year or more prior to the launch date of December 3, 2012 are eligible to participate in the campaign. Applications from investors who do not meet these requirements will not be accepted.
- ✓ To apply for the campaign, the participants are required to sign up on the MKK (Central Securities Depository of Turkey) e-governance portal and submit their application via the portal.
- ✓ This promotion is available for eligible TAV Airports shareholders whose disclosure under the electronic registry system have not been withheld. Applicants who match the criteria will be notified of the promotion by a phone call from TAV and applicants whose verbal approvals are not obtained will not be eligible for the campaign.
